### 2. Why Plan?

The Board works to build **consensus**. This is accomplished by clarifying the following:

- Goals (or issues) to address
- Objectives that indicate success
- Strategies to achieve goals
- Actions to implement strategies
- How to track progress towards achieving goals

### 4. Being a Citizen Planner

Representatives are responsible to:

- Communicate with the municipality/constituency that you represent, to inform them and be aware of their perspectives on proposed Commission decisions;
- Participate in one or more CCRPC Committees to provide oversight of specific Commission programs/projects and to make recommendations to the full Commission; and
- Participate in decisions of the full Commission (typically at CCRPC's monthly meetings).

### 5. Basic RPC Responsibilities

- Prepare studies, plans, and recommendations on a broad set of issues;
- Retain staff and consultant assistance, hold public hearings, and require municipalities and the State to provide information;
- Carry out, with the cooperation of member municipalities, programs for the appropriate development and use of the region's physical and human resources; and
- Perform other acts or functions that the RPC deems to be necessary or appropriate.

### 6. <u>RPC Duties</u>

- Promote the mutual cooperation of member municipalities and cooperate with neighboring states, regions, counties, and municipalities;
- Assist and advise municipalities in the preparation of plans, studies, and Bylaws regarding the appropriate development and use of the region's physical and human resources;
- Prepare a Regional Plan at least every five years;
- Review proposed State capital expenditures for compatibility with the RPC's Regional Plan and assist municipalities in assessing compatibility with municipal plans;
- Appear before District Environmental Commissions to aid in Act-250 reviews and appear before the Public Service Board to aid in *Section-248* reviews of proposed utilities; and
- Confirm municipal planning programs and approve municipal plans.

# 7. Basic MPO Duties

- The MPO has the authority of Federal law
- It is a representative group of local stakeholders and leads the transportation planning process for the metropolitan area
- It is the region's policymaking organization responsible for prioritizing transportation initiatives
- It carries out the metropolitan transportation planning process in cooperation with VTrans and transit operators

### 8. Basic MPO Requirements

- Reflect
  - The "3C" planning process
  - The eight SAFETEA-LU planning factors
- Develop
  - Unified Planning Work Program (UPWP)
  - Public Participation Plan (PPP)
- Produce and Maintain
  - Metropolitan Transportation Plan (MTP)
  - Transportation Improvement Program (TIP)

#### 9. Role of Committees

- Committees are the Primary Reviewer of Issues
  - Focus attention on most critical issues
  - Present questions in their proper sequence
  - Ensure sufficient information to make a decision
- Committees Recommend Proposed Actions to Full Commission

#### 10. Communicating Effectively & Promoting Mutual Respect

- Conduct regular outreach with the public
- Seek input beyond board members
- Convey the regional issues back to your local legislative body/organization and relay their perspectives back to the Board and the Committee if relevant
- Provide constructive and timely feedback
- Respect the diversity of thoughts and opinions
- Speak for the Board only when authorized to do so
