### FY2020 Transportation Improvement Program Amendment

Issues

Make the following change to the FY20 TIP.

I-89 Supplemental Signage, Exits 12 - 17 (Project HP147, Amendment FY20-07)

- Description of the Change: Add a new project to the TIP in FY20 to ► add supplemental signage at all I-89 exits in Chittenden County identifying the mile marker number. Add \$22,000 in FY20. This project is not subject to CCRPC fiscal constraint limit because it is an interstate project.
- Reason for the Change: In 2009 the Federal Highway Administration × implemented a requirement for interstate exits to be numbered according to the mile marker rather than sequentially. Below is an depiction of what the new signs will look like.



Recommend that the TAC approve the proposed TIP amendment.

Dan notes that 11 modeling will include school and rural transit. Look to children to pressure adults to change rather than 12 convincing adults to change. Dennis commented about how the actual cap could have a negative impact 13 on the economy. The initial cap will be based on modeling and fuel availability from recent years. 14 Adjustments could be made to reflect needs, economic impacts, etc. Investments made could help bring

#### 17 5. VTrans On-Line Data Management System

18 Maureen Carr of VTrans Traffic Research Unit gave an overview and demonstration of their traffic data 19 management system. This is a Web-based system shared by VTrans and CCRPC. The data is accessed 20 through Vtrans.vermont.gov, then search for "traffic data," click the first result that comes up. The 21 resulting page has AADT reports, link to traffic data, and other resources. Maureen then showed the data 22 portal and described how to navigate map and data displayed. She then logged into the site which displays 23 more information. Raw data is exportable through the "report center" feature. Some of the counts are able 24 to track the type of vehicle (motorcycle, vehicle, truck, tractor-trailer, etc.). Counts occur on state and 25 federal aid routes, CCRPC counts, local road count program.

Crash data is available in a different place on VTrans website. 28

29 CCRPC conducts manual counts at intersections during peak hours (7-9 am, 4-6 pm) and captures cars, 30 trucks/buses, and bicyclists. VTrans is moving away from manual counts and using more 48-hour video 31 counts to help satisfy FHWA requirements. CCRPC also uses video counts to capture data outside of peak 32 hour manual counts. 33

34 6. Status of Projects and Subcommittee Reports (Information Item): Justin noted that the project list on the back of the agenda identifies new projects begun in FY20 and some older ones dropped off. 35 36

- 43 conflicts with commercial drives. Justin is asking for guidance on design from TAC members and
- 44 CCRPC. Reducing number of curb cuts and consolidating drives is of interest along corridor. Dennis
- 45 suggests also looking at what's on either end of corridor for walkers/bikers, such as Dorset St and
- 46 Hinesburg Rd. 47

### FY2019 and FY2020 Transportation Improvement Program (TIP) Amendments

IssuesA Major Amendment is needed to advance the Williston Park & Ride Project.Major amendments required a public hearing. Details of the proposed<br/>amendments are provided below.

Williston Park & Ride (Project IN004A, Amendment FY20-05)

- Description of Change Advance \$2,300,000 in federal funds from FY19 to FY20 and add \$175,000 for preliminary engineering, \$372,000 for right of way and \$1,675,000 for construction. The new total project cost is \$7,100,000. This is a 57% increase which is a Major Amendment according to CCRPC's TIP Amendment Policy. This change will apply to the FY20 year of the FY19-22 TIP, which is still in effect, and the FY20 year of the FY20-23 TIP which has not yet been approved by FHWA.
- Reason for Change The proposed access drive to the Park & Ride lot has been relocated to consolidate driveways with a new Vermont State Police building to be constructed south of the Park & Ride lot location. Relocating the access drive requires a number of changes including relocating turn lanes, updated stormwater permits, a water/wastewater permit, and an amended Act 250 and a DRB permit. VTrans representatives will attend the TAC meeting to provide more specific information.

#### Champlain Parkway, Burlington (Project HC001A, Amendment FY20-06)

- Description of Change Move \$3,000,000 in federal funds from FY20 to FY23.
- Reason for Change The TIP is a fiscally constrained document. Champlain Parkway has over \$13,000,000 in federal funds in FY20 and the current spending profile for the project indicates that the project will not spend that much. \$10,222,501 remains in FY20 which will be adequate to cover project expenses.
