## **Terminology**

- <u>Contact</u> individual name and set of contact information and location(s)
- <u>Subscriber</u> public account for individuals to manage their own contact information and sign up for specific areas and message types
- <u>Manager</u> designated trusted personnel with Everbridge accounts for sending notifications and managing groups
  - Dispatcher can manage and send notification templates, manage scheduled notifications, and manage active notifications. Can access Dashboard, Universe, and Notifications.
  - Group Manager can manage and send notifications to predefined sets of contacts/subscribers. Can access Dashboard, Universe, Notifications, Contacts, and Reports.
  - Data Manager can only manage contact records (add, edit, and remove). Can access Contacts and Reports.
- Organization Everbridge container for a set of contacts, groups, roles for managing contacts and groups, and roles for sending notifications
- <u>Location</u> geographic area (physical address) for which a user signs up to receive notifications

- Everbridge App
- SMS (1 and 2)
- **Email** (1 and 2)
- Phone (Work Mobile, Personal Mobile, Home, Work)
- TTY/TDD (Teletype / Telecommunications Devices for the Deaf)

- VT-Alert will use ALL delivery methods that are available and selected
- Confirmation allows users to acknowledge notification before escalation
- Edit notification settings to limit methods

IPAWS alerting is withheld at state level.

## Why VT-Alert?

- Access to an existing pool of users who have created accounts for the past three plus years
- Access to reverse E911 data
- Funded by the Emergency Management Performance Grant (EMPG)
- 24/7 Support via Everbridge
- Everbridge uses Amazon Web Services (AWS) for cloud storage and servers
- New established contract with the State of Vermont and Everbridge until December 31, 2022



















## **Municipal Use**

- Towns and cities can adopt VT-Alert
- Used for public safety messages
- Limited to municipal boundaries
- Typical notifiers: Emergency Management Directors, police/fire officers, highway foremen

 Incident Commanders can always send VT-Alert messages through VEM Watch Officer
