- c) Co-Benefits: elements of metric included but not limited to
- Flood Resilience / Hazard Mitigation (other than flood resilience) / Education / Ecosystem Improvement (recreation/tourism, water supply, carbon sequestration, pollutant filtration) / Local Pollution Prevention: (nitrogen, metals/pathogens, other contaminant) / Habitat Improvement (restores habitat and/or connectivity, promotes native species and/or removes native species, protects RTE species, protects significant natural communities) / Other Environmental Benefits not noted above / Part of a project that also addresses a Permit Requirement of a Public or Non-Profit Entity / Community Support / Environmental Justice (engagement, honors knowledge, access to clean water & food, protects sacred resources) for Vulnerable communities / Services to General Public: aesthetics, recreation, mental health, etc.
