JACKI MURPHY MADE A MOTION, SECONDED BY CHRIS SHAW, TO APPROVE THE FULL PETITION APPLICATION LETTER. MOTION CARRIED UNANIMOUSLY.

5. FY23 UPWP and Budget Mid-Year Adjustment

Charlie referred members to the FY23 Mid-Year Budget and UPWP Draft documents included with the packet. He and Forest created three versions of the draft budget. He said this is the first time the CCRPC has been in a situation with an increase in ACCD funding which came between the time when the budget was adopted and the mid-year. Charlie said this this is a big budget. With a total revenue amount of \$7,638,296 it is the largest we have ever had. Charlie highlighted various items, including the following:

- Charlie reminded members the CCRPC applied for and received the US Department of Transportation RAISE Grant. The grant is \$2.1 million dollars to be spent over a three-year period. He explained it will take some time to be under a formal contract. The CCRPC has staff and consultant dollars allocated to this and pointed out the budget line of \$100,000 for consultants. He explained, in terms of staffing levels, we are currently stretched thin and will likely need to bring in a consultant to serve as project manager. The first step will be sending out Requests for Proposals (RFP's). The scope of the work includes Transit Oriented Development plans for up to 12 communities within the Northwest region of Vermont in counties of Addison, Franklin, Washington, Chittenden, and Rutland. The project is focused on communities that have rail lines. CCRPC has asked municipalities to return a commitment letter by January 20, 2023. This will provide us with a clear idea of which towns are interested. This project will be a part of the FY24 work program.
- We expect to have close to \$100,000 in Brownfields monies coming in, however, we did not receive the Brownfields Grant through the EPA. We will apply again next year.
- There is also \$6,500 in new funding for a floodplain map and bylaw update project. We have a contract with Department of Environmental Conservation (DEC).
- The health department has a hot weather emergency response project with \$6,676 budgeted.
- There is \$16,286 in Broadband funding budgeted in staff time for Communications Union
 District (CUD). The CCRPC is facilitating this process. We do not expect to support long term,
 but we will help get this started. There may be a total of \$300,000 coming through our
 budget.

 Chris asked if the \$60,000 on the Regional Planning Grant ACCD line was separate? Charlie said yes, it is being distributed between a few different projects. Charlie said with all the work coming our way, hiring additional staff was also worked into one of the budget versions as well as the proposal for a midyear bonus for current staff. Charlie asked members to weigh in on these.

 Jeff Carr agreed with this approach. He said during the present climate, particularly with the labor market and the status of funding flowing our way, the CCRPC is currently in the "golden age "in terms of finances. He cautioned there could be a very different picture over the next three or four years and we don't want to be in a position where we must let staff go. Charlie said several staff members are looking at retiring over the next few years, and staff reductions, if needed, will occur naturally through attrition.

 Mike O'Brien asked what the excess revenue will do to the indirect rate and wondered if we need to explain the increase in local dues to the towns because we have a surplus. Charlie said he and Forest examined the indirect rate today and found very minimal impact. He explained we want to increase our reserves to the goal of 3 months of expenses to protect the municipalities. Chris agreed taking care of employees is a benefit for the future. He asked what the proposed bonus amount is. Charlie said he would like to give \$1000 per employee which totals \$19,000. Jacki Murphy asked if there were enough funds in the salary budget line to cover hiring new staff and bonuses. Charlie explained there is an \$80,000 difference between the versions. Jacki agreed that staff bonuses were a good idea. Bard Hill agreed and said the bonuses are warranted considering inflation. Bard wonders if it is possible to hire out temporary term employees, working in more of a consultant basis. Catherine also agreed with hiring another staff member and with the proposal of mid-year bonus.

JEFF CARR MADE A MOTION, SECONDED BY JACKI MURPHY, TO RECOMMEND THE BOARD APPROVE THE PROPOSED FY23 MID-YEAR ADJUSTMENT BUDGET #3 AND UPWP. MOTION CARRIED UNANIMOUSLY.

Jeff Carr proposed we think about evaluating our current financial situation and provide a predictor for the next few years to ensure we do not overextend. Charlie agreed and said as an organization it is also about monitoring what is happening with legislature. We usually have a few months' notice when funding is going to be discontinued or added.

The financial portion of the meeting concluded at 6:43 PM and Jeff Carr excused himself.

6. Equity Update

 Charlie asked Anne Nelson Stoner to provide an Equity Update. Anne Nelson said there is a community meeting scheduled for the evening of Thursday, January 5 at our CCRPC office. She is currently working on the CCRPC's internal equity statement, the South Burlington Climate Action Plan, and the Winooski Walk-Bike plan. She is conducting a lot of community outreach and getting to know many people. There were no questions from members.

7. <u>Legislative Priorities:</u>

Charlie referred members to the <u>Policy Participation Topics</u> document included with the packet. The list includes 14 separate topics to be discussed at the January Board meeting. Charlie reviewed the topics. Chris Shaw said <u>item 4. Housing Bill including Permit Process Reform</u> is a hot topic. Chris also said, in Massachusetts, there are state mandates that are meeting some resistance. In towns served by public transit, zoning for multi-family housing is encouraged for density purposes. This is not necessarily a model that works in Vermont currently, but it might be good to approach this subject. There is a point of emphasis we can make on maximizing areas of density.

Charlie said there has been talk about a state planning office that would serve to help guide policy. This is a long-term plan. As an alternative, Rep. Bongartz is asking RPCs to look at how to strengthen the role of regional plans in <u>House Bill 5</u>.

8. Chair Director Report

a. <u>Chittenden County Communications Union District.</u>
 Charlie said the vote for a CUD passed in five municipalities: Essex, Essex Junction,
 Shelburne, South Burlington, and Williston. The organizational meeting of the CC CUD Board will be meeting held tomorrow. Charlie and Ann Janda will represent the CCRPC in this

endeavor and with the start up. We are not looking to stay on as staff. We are only helping with the start up.

b. Municipal Building Energy Resilience Grant Program

5 Charlie said there is over \$40 million dollars in funding and the contract document Act 172 6 Grant Agreement was recently signed by Catherine. This is \$200K worth of work for us to 7 lend support over the next three years. There are some questions about the criteria to be 8 considered as a cost burdened community and Chittenden County does not necessarily 9 score well. Charlie is hoping there will be more discussion on how the factors are determined. He said the Legislature wanted to enable smaller towns will little staff to apply 10 11 for this. Bard said the counties in Vermont are a hypothetical construct. If we cluster Winooski high school with Mt. Mansfield, the average doesn't describe either place very 12 well. He wrestles with this, because within Chittenden County there are isolated cohorts of 13 14 disadvantaged groups. He feels the overall data may not work because it masks the 15 subtleties that exist. Charlie agreed.

The Chittenden County Regional Planning Commission's (CCRPC) Staff and Executive Committee have reviewed this Act 250 application for the above-referenced project described as the development of approximately 102 acres of land including subdivision of 42 new lots, construction of 155 dwelling units and construction of infrastructure improvements consisting of 7608 feet of roadways, recreation paths and sidewalks. The project is located in South Burlington, Vermont, adjacent to Old Farm Road, Kimball Avenue, Kennedy Drive and Eldredge Street. The City of South Burlington Planning Commission has approved the project.

CCRPC understands that full findings of fact are requested for the residential, infrastructure, and park space components of the project (including lots 16, 18-20, 24, 31-39, 47-48), and only Master Plan findings are requested for the remaining lots (17, 21-23, 25-30, 40-46, 49-57).

CCRPC offers the following comments on the proposed project:

The proposed project is located within two Planning Areas as defined in the Chittenden County Regional Plan, entitled the 2018 Chittenden County ECOS Plan.

The residential and some commercial components of the project are in the Metro Planning Area. CCRPC finds these proposed components of the project to be consistent with this planning area for the following reasons:

- The Metro Planning Area is identified in the Plan as an area planned for growth, and therefore the proposed project helps implement Strategy #2 of the Plan, which calls for 80% of new development in the areas planned for growth. The Metro Planning Area is identified in the plan as an area that provides for jobs and housing in a compact development pattern.
- 2. The proposed project is served by municipal water and sewer, is in proximity to public transit, and is within walking distance to many services/jobs.
- 3. The proposed land uses are consistent with the local regulations, as evidenced by the City of South Burlington's approval of the project.

The industrial/commercial component of the project is in the Enterprise Planning Area. CCRPC finds this proposed component of the project to be consistent with this planning area for the following reasons:

- 1. The Enterprise Planning Area is identified in the Plan as an area planned for growth, and therefore the proposed project helps implement Strategy #2 of the Plan, which calls for 80% of new development in the areas planned for growth. The Enterprise Planning Area is identified in the plan as an area planned for a concentration of employment uses that attract workers from the County and multi-county region.
- 2. The proposed project is served by municipal water and sewer, is in proximity to public transit, and is within walking distance to many services/jobs.
- 3. The proposed land uses are consistent with the local regulations, as evidenced by the City of South Burlington's approval of the project.

Therefore, CCRPC finds the proposed project to be in conformance with the Planning Areas of the 2018 Chittenden County ECOS Plan.

The Traffic Impact Analysis (TIA) dated 3/30/2022, and associated supporting documents, assembled by Lamoureux & Dickinson Consulting Engineers, TCE, and WCG were reviewed. The CCRPC would like to clarify that the VT 116/Kimball Avenue/Tilley Drive Area Land Use & Transportation Plan analyzed the transportation network effects of constructing Exit 12B. The study does not recommend or endorse the construction of Exit 12B. The I-89 2050 Study further evaluated Exit 12B along with a full build-out of Exit 13 and reconstruction of Exit 14. The final I-89 Implementation Plan (https://envision89.com/) recommends initiation of a NEPA process for Exit 12B and Exit 13, as a long-term alternative, once certain conditions are met as articulated in the plan.

The CCRPC sincerely appreciates the additional Technical Memorandum dated 1/18/2023 that examined the effects of exclusive pedestrian phases at the Kennedy Drive intersections. The proposed development is anticipated to increase walking and biking which the CCRPC fully supports. With transportation planning becoming increasingly multimodal in nature it is critical to understand the effects of pedestrian phasing on intersection capacity. Reductions in intersection levels of service when pedestrian phases are utilized should be an acceptable tradeoff in areas planned for growth.

The CCRPC does not have any concerns with the proposed development's effects on traffic. We further commend the use of connected roads and gridded streets in the project's layout. This design improves roadway capacities and emergency response times by providing multiple access points.

Due to the detailed level of development review in most Chittenden County municipalities, and the environmental permit reviews at the Vermont Department of Environmental Conservation, CCRPC focuses its Act 250 reviews on the type of proposed land use and the Planning Areas section of the 2018 Chittenden County ECOS Plan. The CCRPC also focuses its review on transportation-related issues, where appropriate, in accordance with the Metropolitan Transportation Plan, which is within the 2018 Chittenden County ECOS Plan.

These comments are based on information currently available; we may have additional comments as the process continues.


